ALTAGAS ANNOUNCES MONTHLY DIVIDEND

Calgary, Alberta (September 10, 2010) – AltaGas Ltd. ("AltaGas") (TSX: ALA) today announced that the September dividend will be paid on October 15th, 2010 to holders of record on September 27th, 2010, of common shares. The ex-dividend date is September 23rd, 2010. The amount of the dividend will be \$0.11 for each common share.

AltaGas has a Dividend Reinvestment and Optional Share Purchase Plan for eligible Shareholders of AltaGas. Eligible Shareholders may reinvest the cash dividends paid by AltaGas on their common shares toward the purchase of new common shares at a five percent discount to the average market price as defined in the Dividend Reinvestment and Optional Share Purchase Plan.
