

**ALTAGAS LTD. ANNOUNCES MONTHLY DIVIDEND****Calgary, Alberta (June 11, 2012)**

AltaGas Ltd. ("AltaGas") (TSX: ALA) today announced that the June dividend will be paid on July 16, 2012, to holders of record on June 25, 2012, of common shares. The ex-dividend date is June 21, 2012. The amount of the dividend will be \$0.115 for each common share. This dividend is an eligible dividend for Canadian income tax purposes.

AltaGas has a Dividend Reinvestment and Optional Share Purchase Plan ("DRIP") for eligible Shareholders of AltaGas. Eligible Shareholders may reinvest the cash dividends paid by AltaGas on their common shares toward the purchase of new common shares at a five percent discount to the average market price as defined in the DRIP.

AltaGas is an energy infrastructure business with a focus on natural gas, power and regulated utilities.
