ALTAGAS FOURTH QUARTER 2010 AND YEAR-END RESULTS AND CONFERENCE CALL ADVISORY, MONTHLY DIVIDEND ANNOUNCEMENT

Calgary, Alberta (February 11, 2010) – AltaGas Ltd. ("AltaGas") (TSX: ALA) will release its 2010 fourth quarter and year-end financial results on Thursday, February 24, 2011. A conference call and webcast to discuss the results and updates on Company developments will be held the same day.

AltaGas also announces that the February dividend will be paid on March 15, 2011 to holders of record on February 25, 2011, of common shares. The ex-dividend date is February 23, 2011. The amount of the dividend will be \$0.11 for each common share. This dividend is an eligible dividend for Canadian income tax purposes.

AltaGas has a Dividend Reinvestment and Optional Share Purchase Plan for eligible Shareholders of AltaGas. Eligible Shareholders may reinvest the cash dividends paid by AltaGas on their common shares toward the purchase of new common shares at a five percent discount to the average market price as defined in the Dividend Reinvestment and Optional Share Purchase Plan.
