ALTAGAS ANNOUNCES MONTHLY DIVIDEND

Calgary, Alberta (June 10, 2011) – AltaGas Ltd. ("AltaGas") (TSX: ALA) today announced that the June dividend will be paid on July 15, 2011, to holders of record on June 27, 2011, of common shares. The ex-dividend date is June 23, 2011. The amount of the dividend will be \$0.11 for each common share. This dividend is an eligible dividend for Canadian income tax purposes.

AltaGas has a Dividend Reinvestment and Optional Share Purchase Plan ("DRIP") for eligible Shareholders of AltaGas. Eligible Shareholders may reinvest the cash dividends paid by AltaGas on their common shares toward the purchase of new common shares at a five percent discount to the average market price as defined in the DRIP.
